SUBMISSION REQUIREMENTS

- A completed Tree Removal Permit Application.
- Provide a description and site plan or survey/map of the proposed tree removal work, including the number, size and location of the trees to be cut down. Detail should be enough for the Tree Warden to easily find the trees. Place a ribbon (one color only) around trees to be removed. Do not mark the trees with a permanent substance such as paint.
- All tree removal debris needs to be removed from the property unless used for mulch and/or firewood. Firewood needs to be neatly stacked and location must comply with setbacks.
- Dead trees require a permit, \$75 permit fee, and inspection by the Code Enforcement Inspector or Tree Warden.
- The Village may require the planting on private property of the same species or an agreed-upon alternate species of specimen or non-specimen trees which are as nearly comparable in type and size as practical to the trees to be removed, destroyed or affected by the alteration, when the individual character of the specimen or non-specimen trees or the ecological setting requires special consideration, as a condition for the issuance of a permit for removal, destruction or alteration. The location for planting of the replacement trees shall be specified prior to issuance of the permit for removal.
- For an application that pertains to a property for which a prior tree removal permit was issued within the past 24 month period, or for a property where trees were removed without a removal permit, the permit fee shall be calculated using the total number of all trees that have been and will be removed, charged at the highest applicable rate per tree.

- Buffer Areas

No existing live tree or shrub of any size shall be removed from the buffer areas without first filing an application with and securing approval from the Village. The buffer area is defined as the twenty-foot-wide vegetated area on a lot contiguous to its side and rear boundary lines, excluding the side boundary line which is contiguous to a street on a corner lot.
